**TAX LEVY ORDINANCE
ROAD DISTRICT
ORDINANCE NO. 2023-04**

An ordinance levying taxes for all road purposes for Carbondale Township Road District, Jackson County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Carbondale Township, Jackson County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Carbondale Township Road District on 8 December, 2022 does hereby determine and declare that the sum of Four Hundred and Sixty-eight Thousand Six Hundred Fifty Dollars (\$468,650.00) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:

General Road Fund, Joint Bridge Fund, and Equipment and Building Fund for the year 2023.

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 4: That the Board of Trustees does hereby certify that the amount levied herein is necessary to be raised by taxation for road purposes for Carbondale Township Road District.

SECTION 5: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not effect the validity of the remaining portion of this ordinance.

SECTION 6: That this ordinance shall be in full force and effect after its adoption, as provided by law.

ADOPTED this eighth day of December, 2022 pursuant to a roll call vote by the Board of Trustees of Carbondale Township, Jackson County, Illinois.
