An ordinance levying taxes for all town purposes for Carbondale Township,
Jackson County, Illinois, for the tax year 2022, collectable in 2023.

BE IT ORDAINED by the Board of Trustees of Carbondale Township,
Jackson County, Illinois, as follows:

SECTION 1: That the sum of One Million, One Hundred Eight Thousand Five Hundred
Dollars (\$1,108,500) is hereby levied upon all property subject to taxation within the
Township as that property is assessed and equalized, in order to meet and defray
all the necessary expenses and liabilities of the Township as required by statute or voted
by the people in accordance with the law, for such purposes as:

General Corporate, Fireman's Pension,
Fire Equipment, Illinois Municipal Retirement,
and General Assistance for the year 2023.

SECTION 2: That the amount levied for each object and purpose shall be as follows:
